**FOAMBUSTER™ MAX IS NOT FOR AQUATIC USE**

Use FOAMBUSTER™ MAX at one to two ounces per 100 gallons of spray solution. It may be necessary to adjust the amount used according to individual conditions. It is always best to add to tank mixture *before* pesticides or other adjuvants. This will keep foam from forming. If foam has already formed, add a zig zag pattern over foam. FOAMBUSTER™ MAX is compatible with most chemical and fertilizer mixtures.
